

## RIDEOUT REPORT

### CRRG MYSTERY SPIN 2012

Sat. 8<sup>th</sup> September 2012

## C.I.R.A.

(Clay-pigeon International Rules Association)

Report on CRRG Competition on 8<sup>th</sup> September 2012

**This Report is legally binding and the findings are not open for Appeal.**

The Investigation Team took statements from the Instructors. The Team also sent blood and urine samples from all the CRRG competitors for analysis. The following are the findings of the investigation.

### **BLOOD & URINE RESULTS**
